**DECLARATION OF GINA INTREPIDO-
BOWDEN REGARDING SETTLEMENT
ADMINISTRATION EXPENSES**

1 I, Gina Intrepido-Bowden, hereby declare as follows:

2 1. I am a Vice President at JND Legal Administration LLC (“JND”). This Declaration
3 is based upon my personal knowledge, as well as upon information provided to me by experienced
4 JND employees and Class Counsel and Counsel for Defendant (“Counsel”), and if called upon to
5 do so, I could and would testify competently thereto.

6 2. JND is serving as the Settlement Administrator in the above-captioned litigation
7 (“Action”) for purposes of administering the Joint Stipulation and Settlement Agreement
8 (“Settlement Agreement”) as ordered by the Court in its Preliminary Approval Order (“Order”)
9 (Dkt. 89), dated August 11, 2023. I previously submitted the Declaration of Gina Intrepido-
10 Bowden Regarding the Proposed Settlement Notice Plan (Dkt. 82-4) on June 26, 2023.

11 **SETTLEMENT ADMINISTRATION EXPENSES**

12 3. Settlement Administration Expenses mean all Class Notice and administrative fees,
13 costs, or expenses incurred in administering the Settlement, including those fees incurred by the
14 Settlement Administrator. As of August 20, 2023, JND has incurred \$9,137.73 in Settlement
15 Administration Expenses.

16 4. JND estimates the remaining Settlement Administration Expenses are expected to
17 be approximately \$53,382.27, including work in connection with the Class Notice and distribution
18 mailings.
